I. Call to Order

VII. Special Presentation: Oxford House

All

Gregory Keeley presented on the self-run recovery home Oxford House. The program has six homes in Miami-Dade County. He reviewed the Oxford Impact report and provided background on the founding of the program in 1975 and opening its first house in Florida in 2019. Unlike traditional recovery homes the homes are member-driven and run democratically. Members vote on new members, share bills, and pay weekly. Members are required to attend three to five substance abuse recovery meetings while they stay in the home, and contribute to the upkeep of the space. Members apply directly to each home which charges a \$150-\$200 non-refundable application fee, then an interview is conducted. All the current members living in the home vote and if eighty percent agree you are welcomed in. Rooms are shared and payments are due Sundays. The homes generally have 6-12 members and are large size and are single sex. Homes are near public transportation, job opportunities, and twelve step programs. The average stay in a home is eighteen months. Members will need to begin employment within two weeks of starting to support themselves. Members are also required to have a sponsor, and no overnight guests are allowed. Members can be voted out for returning to substance use, not paying, threatening violence, or not doing their fair share of housework. The program is contracted through the Florida Department of Children and Families.

Roberto Tazoe was not present to provide a report, but Marlen Meizoso indicated that based on the report given at the Partnership meeting the program will have a shortfall. Conversations with HUD have not taken place on possible solutions because of the government shutdown.
